## Global Speakers



### Hon. Baroness Sandip Verma , U.K

She is an Indian-English politician in the United Kingdom. An appointed member of the House of Lords, she is Ministerial Champion for Tackling Violence Against Women and Girls Overseas, a role she has held since 13 May 2015, and was previously the Parliamentary Under Secretary of State for International Development from 2015 to 2016.



### Hon. Chris Philp M.P, U.K, Patron - WHD

He is a Conservative Party politician. He was elected in May 2015 as the Member of Parliament (M.P) for Croydon South. Philp was voted London's Emerging Entrepreneur of the Year by Ernst & Young and The Times in 2003, alongside being voted the CBI's Entrepreneur of the Future, 2005. In 2005, Philp was listed as one of the UK's top 50 entrepreneurs by startups.co.uk.



### Hon. Angela Guerra, M.P, Portugal

After obtaining a degree in law at the University of Lisbon, Dr Guerra qualified as a notary at the Faculty of Law of the University of Coimbra. She is a Former President of the Pinhel Municipal Assembly, Vice President of the PSD Council of Pinhel, and has been the Vice Chairperson of the Board of the Pinhel Municipal Assembly for 12 years. She served as Director of the Administrative and Financial Department of the Municipality of Almeida, and President of the Attorneys Association's Delegation in the Region of Pinhel.



### Hon. Sandra Pereira, M.P, Portugal

A native of Lisbon, was a member of the Municipal Assembly of Odivelas from 2001 to 2009. She is a Lawyer and Member of the Parliamentary Assembly of the Republic of Portugal for the Social Democratic Party (PSD). In Parliament, she is a full member of the Committee on Constitutional Affairs, Rights, Freedom and Guarantees of the Subcommittee on Non-Discrimination and Equality, as well as the Euthanasia Working Group. She is a full time member of the 10<sup>th</sup> Commission Committee on Labour and Social Security and is a member of the Working Group on Disability.



### Hon. Abdel Majid Fassi Fihri, M.P, Morocco

He graduated from Al Akhawayn University (Morocco) in 2007 with a Bachelors Degree in Communication Studies. He later earned his Post Graduate Diploma in Politics and Mass Media at the University of Liverpool (U.K) and a Masters Degree in Media Practice at the University of Sydney (Australia). Between 2009 and 2016 he worked as Charge de Mission at the Directorate General of the Moroccan National Television (SNRT). Member of the Istiqlal Party, he was elected to the Parliament in 2016 and is currently the Vice-President of the Committee on Education, Culture and Communications. He is also The Chairman of IYDU.



### Dr Raghavan Seetharaman, CEO, Doha Bank, Qatar

He is the Group CEO of Doha Bank (DSM:DHBK) set up in 1978, Doha Bank is one of the largest commercial banks in Qatar. In 2015, business magazine Forbes ranked Seetharaman 6th in the Forbes's Top Indian Leaders in the Arab World 2015 list. He was named CEO in September 2007. Since then he has overseen the bank's expansion from its base in Qatar to the UAE, India, Singapore and China.

He is the Operations Vice President of BRICS International Forum, He is the Founder and President of International Diplomatic Club "Amicability", he supports culture and art. He has also established the international spiritual theater "Veda-Renaissance"

She is a South Sudan politician who was State Minister of Energy and Mining in the Khartoum-based Government of National Unity between 2005 and 2010. In November 2003 Angelina Teny facilitated a conference of South Sudan Women on "The House of Nationalities", held in Lokichokio, a concept designed to foster peace and national unity through recognition of diversity.
